COMMITTEE REPORTS:

- A. Code Enforcement/Zoning Officer:
 - o 20 Cowanesque Street has a lien on it for vermin eradication. The owner cannot be located so no further action on other zoning issues can be taken because the owner cannot be found.
- B. Public Works/Streets and Dikes:
 - Streets to be Swept April 9th.
 - o Larry will update on ground hog hole filler at the next meeting.
 - o Bobby Scott will meet with Brad Hackett, EMC, regarding an Emergency Action Plan for the dikes. (a levee inspection report action item).

- Encroaching items will need to be moved 10 feet from the dike toe. (a levee inspection action item)
- o Current water filter manufacturer is obsolete.
- Researching if water plant filtration system should be replaced with pod system or just replace the current filtration with new greensand. The current greensand replacement permit is still valid.
- Well 2 is being put on-line after years of being off-line. This will help avoid employee overtime.
- C. Public Works/Parks & Recreation:
 - o The Cherry Street Park was awarded \$1,000 for new mulch.

 - o The sewer plant was hydraulically overloaded every day in the month of March 2018.
 - o Larsen Design Group is seeking alternatives to sludge management for the winter months, as having the sludge hauled off is a costly venture.
 - o There is now a 500-gallon tank at the sewer plant for off-road diesel.
 - o There is now internet access at both plants, opening the door at the water plant for the water probe to be given to the borough by the county for the water monitoring system.
 - o Standard Operating Procedure for the Chlorine Rooms at both plants is written, posted and to be followed. Both chlorine rooms are now safety-compliant for our employees.
 - o The 2018 Lawrenceville Borough Authority budgeted revenue is for \$282,000. It appears that the revenue run rate after the first quarter of 2018 will be \$380,000. The discrepancy is being researched.
 - 61 Main Street has been sold, is being torn down and replaced with senior apartments.
 Right now, a permit cannot be issued due to the DEP EDU (Equivalent Dwelling Units) limits.
